


#### Over half support Labour's plan to end the VAT exception offered to private schools

Starting 1 January 2025, the Labour government will require VAT at the standard rate of 20% to be added to private school fees. If private schools decide to increase school fees as a result, then someone currently paying £15,000 a year per child for school fees would pay around £18,000 instead.

Labour has said this will raise around £1.5 billion a year that can be spent on improvements to state schools (e.g., non-private schools). However, critics say it will mean some families will be unable to afford to keep sending their children to private school.

Based on what you know, do you support or oppose Labour's plan to end the VAT exemption offered to private schools?



How acceptable or unacceptable do you think it is for parents to take their children out of school during term time without the school's permission in each of the following circumstances?








# Around two in five think the fine for unauthorised school absences is about right

As you may know, from August 2024, the fine for unauthorised school absences in England will rise to £80 if paid within 21 days, or £160 if paid within 28 days. This rate is in line with inflation and is the first increase since 2012.

In the case of repeated fines, if a parent receives a second fine for the same child within any three-year period, this will be charged at the higher rate of £160. Under specific circumstances, such as family emergencies, these fines are waived.


The majority of parents have not taken their children out of school without permission to go on holiday or to a family wedding


